THE ELECTRICITY SUB-SECTOR CONTINUES TO SOAR

In the past Five (5) Years of implementation of the National Resistance Movement (NRM) Manifesto (2017 – 2022), Uganda's Electricity sub-Sector has performed exceptionally. For Four (4) times in a row, Uganda's Electricity Regulatory Framework has ranked No. 1 in Africa, according to the African Development Bank Regulatory Index for the years 2018, 2019, 2020 and 2021.

The challenges presented by the COVID-19 Pandemic, natural disasters and high levels of infrastructure vandalism notwithstanding, the sub-Sector has exhibited impressive resilience. With the able Leadership of His Excellency the President and the NRM Government under the stewardship of the Ministry of Energy and Mineral Development, the sub-Sector has made its Contribution to the Country's Socio-Economic Transformation, as highlighted:

Uganda's **Installed Generation Capacity** has grown by **466.69 MW**, to **1,352.52 MW** in the past Five (5) Years, with the commissioning of 26 (Twenty Six) Plants of varied technologies.

In January 2022, following a review of the Tariff Structure, **ERA** commenced the Pilot for a special Tariff of **5 US Cents per kWh for Industrial Parks**. The scheme will be monitored and rolled out once proved viable.

CLEAN ENERGY
ACCESS



ERA introduced a Declining Block Tariff for Domestic Consumers, effective January 2022. With this mechanism, Domestic Consumers pay **Ush. 412 per kWh for a 70-Unit bundle after consumption of 80 Units** in a month. This targets to provide Domestic Customers with Access to Clean Energy for Cooking, a key aspiration of the Country enshrined in the Third National Development Plan.
