APPLICATION FOR THE MODIFICATION OF LICENCE FOR BULK POWER SUPPLY NO. ERA/LIC/BPS/020/193 FOR THE PERIOD 2020 TO 2022.

We refer to your letter dated 12th November 2019 in respect to our Multi-Year tariff review application for the period 2020 – 2022 and License No. ERA/LIC/BPS/020/193 (the License) issued to us for Bulk Power Supply.

Pursuant to the provisions of Section 44 of the Electricity Act, 1999 (Chapter 145 laws of Uganda), which states that "Where in the opinion of a licensee, a condition has become unduly onerous and is impacting on the ability to fulfil its obligations under the license, it may apply in writing to the Authority requiring that the licensee be modified".

We have studied the licence terms and after taking into consideration the operating environment and future outlook in terms of the increasing grid expansion, the required organization structure to deliver on the mandate, UETCL has noticed that there are unduly onerous conditions that require to be modified.

In this regard, we hereby apply for the modification of Uganda Electricity Transmission Company Limited's License No.ERA/LIC/BPS/020/193 for the period 2020-2022 as follows;

a) Provisions of the Licence that require modification

1) Definition of "Tariff Year"

The Tariff Year under definitions page 5 of the License be amended to read "Tariff Year is a period not exceeding twelve (12) months ending June 30th in respect of which the audited financial statements are furnished".

Reason for Modification

In 2017, following Government directive, UETCL changed its financial year end from December to June. This was in line with the Public Finance and Accountability Act 2015 as amended. However, ERA has maintained its tariff year end as Calendar Year, which creates misalignment when it comes to budgeting and budget execution. Therefore, there's need for the Electricity Regulatory Authority to comply and align UETCL's license obligations and tariff provisions to the Government's fiscal year (July to June) in compliance with the Public Finance Management Act, 2015 as amended.

2) Schedule 1: Operating and Maintenance Costs-TOC (Millions).

UETCL proposes that Schedule 1 of the License be modified and replaced with the following Transmission Operating and Maintenance Cost-TOC for the three-year period 2020-2022.
